Gate control of the electron spin-diffusion length in semiconductor quantum wells

The spin diffusion length is a key parameter to describe the transport properties of spin polarized electrons in solids. Electrical spin injection in semiconductor structures, a major issue in spintronics, critically depends on this spin diffusion length. Gate control of the spin diffusion length could be of great importance for the operation of devices based on the electric field manipulation and transport of electron spin. Here we demonstrate that the spin diffusion length in a GaAs quantum well can be electrically controlled. Through the measurement of the spin diffusion coefficient by spin grating spectroscopy and of the spin relaxation time by time-resolved optical orientation experiments, we show that the diffusion length can be increased by more than 200% with an applied gate voltage of 5 V. These experiments allow at the same time the direct simultaneous measurements of both the Rashba and Dresselhaus spin-orbit splittings.

The length scale over which the travelling electron spin keeps the memory of its initial orientation is known as the spin-diffusion length^{1–5}, which is a critical parameter for many spintronic devices^{6–12}. In semiconductors, this distance is closely linked to spin relaxation and spin transport properties of conduction electrons, which in turn depend on the spin-orbit interaction. In quantum wells made of III–V semiconductors such as the model GaAs/AlGaAs system, the conduction-band (CB) spin splitting has two origins: the first one, called Bulk Inversion Asymmetry (BIA) or Dresselhaus term, is the consequence of the combined effect of spin-orbit interaction and the lack of crystal inversion symmetry^{13,14}. The second contribution to the spin splitting, called Structural Inversion Asymmetry (SIA) or Rashba term, exists if the quantum well experiences an electric field^{15,16}. The interplay of these two terms can yield longer relaxation times for electron spins oriented along some specific crystallographic directions^{17,18} or original effects, such as Spin helix^{19,20}. After a few years of debates, it was recently shown that the Rashba-induced conduction-band spin splitting requires the application of a real electric field in the structure (through asymmetric doping or PIN structures), whereas CB potential gradients, which also break the inversion symmetry, yield negligible small Rashba splitting^{13,21,22}.

Thanks to the unique relative orientation of the Dresselhaus and Rashba fields in (111)-oriented semiconductor quantum wells, we show here that the electron spin-diffusion length can be electrically controlled, a feature that was never demonstrated before. Moreover, the all-optical measurement of the electric field dependence of the electron spin-relaxation time and the spin-diffusion coefficient allows us to get a direct determination of both the Dresselhaus and Rashba coefficients independently.

Results

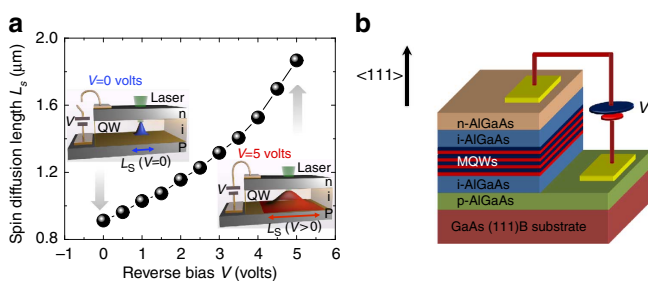


Figure 1 | Gate control of the spin-diffusion length. (a) Variation of the spin-diffusion length $L_s = \sqrt{D_s T_s}$ as a function of the reverse bias V applied on the NIP device obtained from combined measurements of the electron-spin lifetime T_s and the electron spin-diffusion constant D_s . Insets: schematics of the gate control of the electron spin-diffusion length L_s in a (111)-oriented GaAs/AlGaAs quantum well. The red ($V = 5$ volts) and blue ($V = 0$) surfaces illustrate the spatial distribution of the spin density in the quantum well plane under laser excitation. (b) Schematic representation of the NIP junction with 20 GaAs/Al_{0.3}Ga_{0.7}As QWs embedded in its intrinsic region. The growth axis z corresponds to the $\langle 111 \rangle$ direction.

Electric field effect on the spin-diffusion coefficient. Spin-polarized electrons are photogenerated by exciting the non-intentionally doped quantum wells using a circularly polarized laser. The quantum wells are embedded into an NIP structure in which a reverse bias V can be applied, yielding the variation of the electric field E experienced by the spin-polarized electrons (Fig. 1). The spin-diffusion length L_s is simply linked to the spin lifetime T_s and the spin-diffusion coefficient D_s through $L_s = \sqrt{D_s T_s}$ (refs 23,24). We performed an optical measurement of the spin-diffusion constant D_s by using the Transient Spin-Grating

technique²³, and we measured the electron spin lifetime T_s by the time-resolved photoluminescence spectroscopy²⁵ (see Methods).

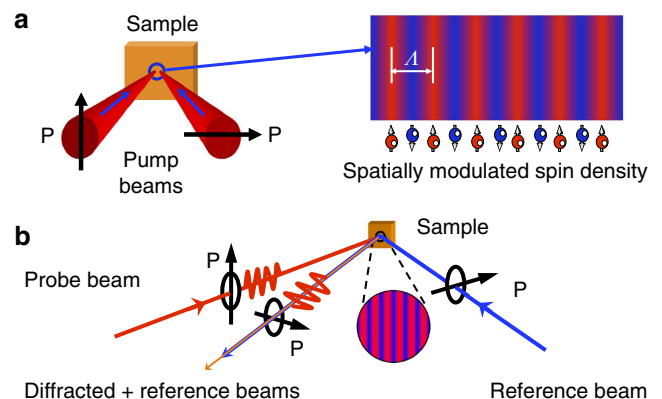


Figure 2 | Transient spin grating. (a) Schematic of the transient spin-grating technique based on the interferences of the two cross-polarized pump beams yielding a spatially modulated spin density in the quantum well plane with a period Λ . (b) The spin-grating signal detected with a heterodyne technique based on a reference beam is recorded as a function of the time delay between the pump and the probe pulses (see Methods).

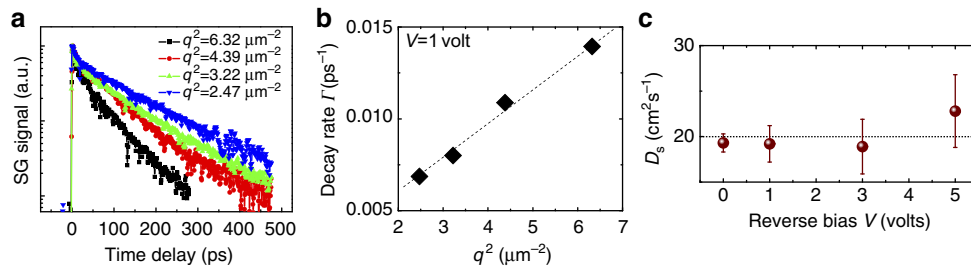


Figure 3 | Electron spin diffusion. (a) Time evolution of the spin-grating (SG) signal as a function of the delay between the pump and the probe laser pulses for $V=1$ volt. To separate the effects of spin diffusion and spin relaxation, the grating decay rate $\Gamma = D_s q^2 + \frac{1}{\tau_s}$ is measured for different grating wave vectors \mathbf{q} by changing the phase mask period (see Methods). (b) Decay rate Γ of the SG signal for a reverse bias $V=1$ volt. (c) Spin-diffusion coefficient D_s as a function of the gate voltage V . The error bars correspond to the uncertainties of the slope determination (see Fig. 3b).

A spin-density wave with wavelength Λ is created by the interferences of two cross-polarized pump laser beams (Fig. 2). The modulus of wave vector \mathbf{q} of the spin grating is equal to $q = 2\pi/\Lambda$. Figure 3a displays the decay of the spin-grating signal as a function of the delay between the pump and the probe laser pulses for a reverse bias $V = 1$ volt. The decay rate Γ of this spin-density wave is simply given by^{23,26}:

$$\Gamma = D_s q^2 + \frac{1}{T_s} \quad (1)$$

To separate the effects of spin diffusion and spin relaxation, the grating decay rate Γ is measured for different grating wave vectors \mathbf{q} by changing the phase mask period (see Methods). Performing the measurement of Γ for different grating periods (and hence q^2 values) yields an accurate determination of D_s , whose dependence on the gate voltage has never been investigated. Figure 3b displays the variation of Γ as a function of q^2 for an applied reverse bias $V = 1$ volt. We measured a spin-diffusion coefficient $D_s \sim 20 \text{ cm}^2 \text{ s}^{-1}$. We performed the same experiments for different applied gate voltages. Figure 3c shows that the spin-diffusion coefficient D_s is almost constant whatever the applied vertical electric field is; this value is consistent with previously reported spin-diffusion coefficients in non-intentionally doped GaAs quantum wells^{27–29}.

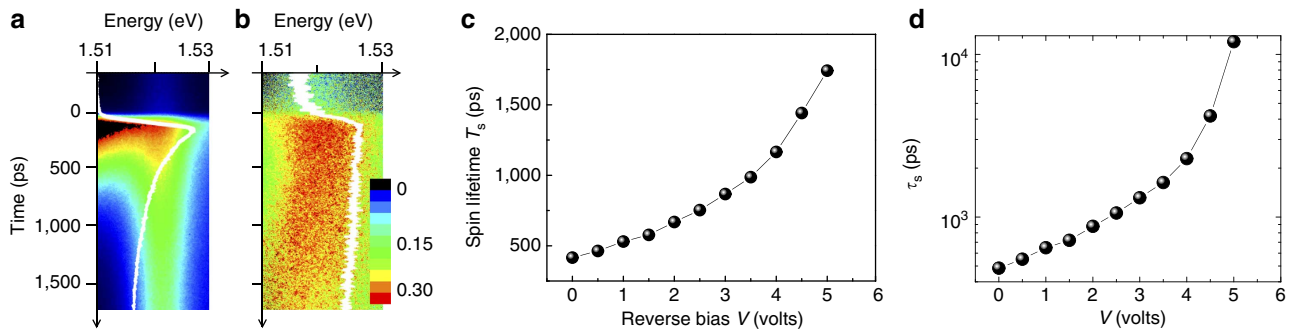


Figure 4 | Spin Lifetime in the gate-control device. (a) Photoluminescence intensity (colour code in arbitrary units) as a function of both time and photon energy for a reverse bias $V=5$ volts. The white curve represents the PL intensity as a function of time when the emission is spectrally integrated. The decay time of this PL dynamics corresponds to the electron lifetime τ . (b) PL circular polarization degree P_c (colour code from $P_c=0$ to $P_c=0.30$) as a function of both time and photon energy for a reverse bias $V=5$ volts. $P_c = (I^+ - I^-)/(I^+ + I^-)$, where I^+ and I^- are the PL circular components, respectively, co- and counter-polarized with the incident laser beam. The white curve represents P_c as a function of time when the emission is spectrally integrated. The decay time of this P_c dynamics corresponds to the electron spin-relaxation time τ_s . (c) Gate control of the electron spin lifetime T_s . (d) Gate control of the spin-relaxation time τ_s .

Gate voltage variation of the spin lifetime. In order to obtain the electric field dependence of the spin-diffusion length L_s , we need to determine the variation of the spin lifetime T_s measured independently as a function of the gate voltage. The striking feature of (111)-oriented quantum well is that the electron spin-relaxation time can be electrically controlled for any electron-spin orientation^{25,30}. The accurate determination of the electric field dependence of the electron spin lifetime T_s has been obtained from spin-polarized time-resolved photoluminescence spectroscopy (Fig. 4a,b). Figure 4c displays the dependence of T_s as a function of the applied voltage, where $1/T_s = 1/\tau_s + 1/\tau$; both the electron spin-relaxation time τ_s and the electron lifetime τ have been measured for each value of the reverse bias V . The electron-spin lifetime can be controlled with the applied electric field with an

increase by a factor of about four when the reverse bias varies from 0–5 volts. We checked that the same gate voltage dependence of T_s was measured by time-resolved Kerr rotation experiments performed on the same set-up as the spin-grating measurements.

Figure 1a presents the resulting variation of the spin-diffusion length $L_s = \sqrt{D_s \tau_s}$ as a function of the applied voltage. It increases by more than a factor two when the amplitude of the electric field increases, reaching a value $L_s \sim 1.8 \mu\text{m}$ for $|E| \sim 55 \text{ kV cm}^{-1}$ corresponding to $V=5$ volts. These results provide the proof of concept that the spin diffusion length can be electrically controlled in semiconductors. Here the increase of L_s is limited by the electron lifetime τ because for $V > 4$ volts the spin relaxation time is much longer than τ in these non-intentionally doped quantum wells (Fig. 4d). In n-doped (111) quantum wells, which are of interest for spintronic applications^{11,12}, we expect a much larger variation of L_s with the applied voltage that will be no more limited by the electron lifetime. In that case, the variation of L_s with the voltage V will just depend on the square root of the electron spin-relaxation time τ_s , which can vary by several orders of magnitude with V ^{25,30}.

Discussion

The all-optical measurements of both the spin relaxation dynamics and the electron spin diffusion allow us to get a precise and independent determination of the Dresselhaus and Rashba coefficients, which are the key parameters to control and manipulate the carrier spins in semiconductors. Despite the numerous experimental and theoretical investigations, the

reported values of the Dresselhaus and Rashba coefficients in GaAs vary strongly, ranging from $|\gamma|=3$ to 35 eV \AA^3 for Dresselhaus^{29,31–35} and r_{41} from 5–10 e \AA^2 for Rashba^{13,29,36}. Most of the techniques used so far give only the ratio between the Rashba and Dresselhaus terms or allow the determination of only one type of spin splitting. They also require the investigation of n-doped quantum wells with electrical contacts^{31,37,38}. The technique presented here, which yields the determination of both Dresselhaus and Rashba spin-orbit (SO) splitting in the same sample, could be applied for any doped or undoped III–V or II–VI cubic semiconductor quantum wells. The only requirement is to grow the structures on (111)-oriented substrates.

In a (111) quantum well, where the momentum component along the growth axis z is quantized, the spin precession vector $\mathbf{\Omega}(\mathbf{k})$ due to the Dresselhaus (BIA) term for the lowest electron subband is written as³⁹:

$$\mathbf{\Omega}_{\text{BIA}}(\mathbf{k}_{//}) = \frac{4\gamma}{\hbar\sqrt{3}} \langle k_z^2 \rangle (k_y, -k_x, 0) \equiv \frac{\beta}{\hbar} (k_y, -k_x, 0), \quad (2)$$

where $\langle k_z^2 \rangle$ is the averaged squared wave vector along the growth direction, $\mathbf{k}_{//}$ is the in-plane wave vector ($k_{//}^2 = k_x^2 + k_y^2$) and γ is the Dresselhaus coefficient⁴⁰. The weaker cubic terms in the Hamiltonian have been neglected here (at 50 K for a well width $L_W = 15 \text{ nm}$, the average cubic Dresselhaus term is 10 times weaker than the linear one). For an electric field applied along the growth axis, the SIA (Rashba) component writes:

$$\mathbf{\Omega}_{\text{SIA}}(\mathbf{k}_{//}) = \frac{2r_{41}E}{\hbar} (k_y, -k_x, 0), \quad (3)$$

where $\alpha = 2r_{41}E$ is the Rashba coefficient (E is the electric field amplitude and r_{41} is a positive constant¹³). In contrast to (001) or (110)-oriented quantum wells, equations (2) and (3) show that the BIA and SIA vectors have exactly the same direction in the (111) QW plane and the same electron momentum dependence²⁵. Thus the total spin precession vector has the form:

$$\begin{aligned}\Omega_{\text{Tot}}(\mathbf{k}_{//}) &= \Omega_{\text{BIA}}(\mathbf{k}_{//}) + \Omega_{\text{SIA}}(\mathbf{k}_{//}) \\ &= \left(\frac{\beta}{\hbar} + \frac{2r_{41}E}{\hbar}\right)(k_y, -k_x, 0)\end{aligned}\quad (4)$$

This spin precession vector will drive the well-known dominant D'yakonov-Perel electron spin-relaxation mechanism in the quantum well. The corresponding spin-relaxation time is given by^{14,41}:

$$\frac{1}{\tau_s} = \langle \Omega_{\text{Tot}}^2 \rangle \tau_p^* \quad (5)$$

where $\langle \Omega_{\text{Tot}}^2 \rangle$ is the mean square precession vector in the plane perpendicular to the electron spin direction (which is here along z) and τ_p^* is the electron momentum-relaxation time⁴¹. Substitution of equation (4) into equation (5) and taking the thermal average yields:

$$\beta + 2r_{41}E = \hbar^2(2m^*k_B T \tau_s \tau_p^*)^{-1/2}. \quad (6)$$

This means that the measurement of both the electron spin-relaxation time τ_s and the electron momentum-relaxation time τ_p^* as a function of the applied electric field gives a direct determination of both the Dresselhaus and Rashba coefficients.

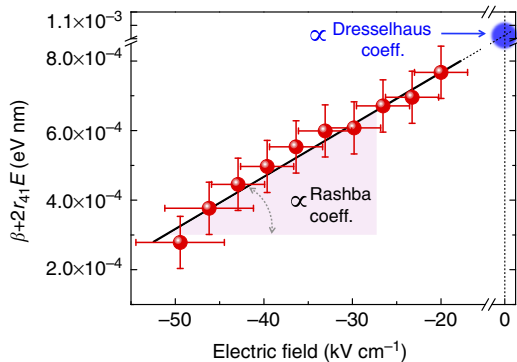


Figure 5 | Simultaneous measurement of the Dresselhaus and Rashba coefficients. Variation of $\beta + 2r_{41}E$ as a function of the applied electric field E in the device. The red triangle schematically represents the slope of this function used to extract the Rashba coefficient r_{41} . The intercept of $\beta + 2r_{41}E$ with the ordinate axis gives β ($\beta = 4\gamma \langle K_z^2 \rangle / \sqrt{3}$), where γ is the Dresselhaus coefficient. The x axis error bars have been calculated from the uncertainties on the measured stark shift. The y axis error bars correspond to the uncertainties on the measurement of the spin-relaxation time τ_s and momentum-relaxation time τ_p^* .

The electron momentum-relaxation time can be obtained from the spin-grating experimental results presented above. On the basis of the Einstein relation, we have $\tau_p^* = (m^*\mu)/e = m^*D_e/(k_B T)$, where D_e is the charge diffusion constant, μ the electron mobility and m^* the electron effective mass. For undoped quantum wells, the electron spin-diffusion coefficient is equal to the electron diffusion coefficient ($D_e = D_s$)²⁹. As a consequence, the spin-diffusion coefficient D_s measured in Figure 3c allows us to measure τ_p^* ; we find $\tau_p^* \sim 200$ fs with no variation with the applied electric field within the experimental uncertainties. Using this τ_p^* value and the measured variation of the electron spin-relaxation time τ_s as functions of the applied electric field, we have plotted in Fig. 5 the curve $\beta + 2r_{41}E$ using

equation (6). From the slope and the intercept of this curve, we get straightforwardly the Rashba and Dresselhaus coefficients ($\langle K_z^2 \rangle = 2.5 \times 10^{16} \text{ m}^{-2}$ is obtained in the framework of a finite QW barrier calculation³¹). We find $\beta = 1.06 \pm 0.1 \times 10^{-3} \text{ eV nm}$ yielding a Dresselhaus coefficient $\gamma = 18 \pm 2 \text{ eV \AA}^3$, whereas the calculated value for GaAs is $\gamma \cong 24 \text{ eV \AA}^3$ (refs 13,35). From the slope of the curve in Fig. 5, we get the Rashba coefficient $r_{41} = 7 \pm 1 \text{ e \AA}^2$, consistent with the calculated value $r_{41} = 5.2 \text{ e \AA}^2$ (ref. 13).

In conclusion, we have demonstrated for the first time the gate control of the electron spin-diffusion length in a semiconductor nanostructure. In addition to its interest for spintronic devices, this effect allows an accurate determination of both Dresselhaus and Rashba coefficients. It can be applied in any zinc-blende III-V and II-VI quantum wells and in wurtzite (0001) nanostructures as well⁴², as the principle relies only on symmetry considerations. We emphasize that this electrical control of the spin-diffusion length is effective whatever the injected carrier spin orientation is. This opens an avenue for spin manipulation and control in semiconductors.

Methods

Sample. The investigated sample is grown on (111)B-oriented semi-insulating GaAs substrate using molecular beam epitaxy. The (111)B substrate is misoriented 3° towards $\langle 111 \rangle A$. The layer sequence of the NIP structure is: substrate/200 nm GaAs buffer/500 nm p-doped ($p = 1.2 \times 10^{18} \text{ cm}^{-3}$) GaAs/100 nm $\text{Al}_{0.3}\text{Ga}_{0.7}\text{As}$ barrier/MQW/70 nm $\text{Al}_{0.3}\text{Ga}_{0.7}\text{As}$ barrier/10 nm n-doped ($n = 2.8 \times 10^{18} \text{ cm}^{-3}$) GaAs (Fig. 1b). The Multiple Quantum Well (MQW) consists of 20 periods of GaAs/ $\text{Al}_{0.3}\text{Ga}_{0.7}\text{As}$ quantum wells with well width and barrier width $L_W = 15$ nm and $L_B = 12$ nm, respectively. The reverse bias voltage (V) is applied between the unetched top n-contact and the chemically etched p-contact.

Spin relaxation and spin transport measurements. In the Transient Spin-Grating experiment, the laser pulses are generated by a mode-locked Ti:sapphire laser with 120 fs pulse width and 76 MHz repetition frequency and are split into primary pump and probe beams with an average power of 5 and 0.5 mW, respectively (Fig. 2a). The wavelength is set to get the maximum signal of Kerr rotation for each reverse bias V through the standard time-resolved Kerr rotation technique¹⁸. Both pump and probe beams are focused on a phase mask (StockerYale, Inc.) with a period d . The phase mask splits each of the primary beams by diffraction into the $m = \pm 1$ orders. The interference between the two pump beams with orthogonal linear polarization yields a spatially modulated circular polarization across the excitation spot. According to the optical interband selection rules, this interference pattern will generate a periodical spin density, called the spin grating. The period A of the transient spin grating is simply $A = \frac{d}{2} \cdot \frac{f_1}{f_2}$, where f_1 and f_2 are the focal lengths of two spherical mirrors. In our set-up, the focal lengths of the first and second spherical mirrors are fixed at $f_1 = f_2 = 30.4$ cm. The spot sizes of both pump and probe beams are $\sim 200 \mu\text{m}$. The wave vector modulus q of the spin grating is equal to $q = \frac{2\pi}{A} = 2.51 \times 10^4 \text{ cm}^{-1}$ with a phase mask of $d = 5 \mu\text{m}$. Phase masks with $d = 5, 6, 7$ and $8 \mu\text{m}$ are used. A delayed probe beam with vertical linear polarization is incident on the spin grating and the corresponding diffracted beam is detected as a function of the time delay between the pump and the probe pulses (Fig. 2b). A heterodyne detection of the transient grating is implemented using a reference beam with horizontal linear polarization incident on the sample⁴³. The four beams (two pump beams, probe and reference beams) are arranged in the boxcar geometry⁴³. In this scheme based on two lock-in amplifiers, the pump beam is modulated by a photoelastic modulator with a frequency of 100 kHz, and the probe beam is mechanically chopped at 60 Hz. This heterodyne configuration yields an increase in the signal to noise ratio by more than two orders of magnitude. The spin-grating signal (proportional to the modulus the electric field of the diffracted probe beam) is simply given by $I_{\text{SG}} = A \exp(-\Gamma \Delta t)$, where A is a constant, Γ is the decay rate of the spin grating and Δt is the time delay between the pump and probe pulses. The electron spin-relaxation time τ_s and electron lifetime τ are measured from time and polarization resolved photoluminescence experiments using circularly polarized picosecond Ti:Sapphire laser pulses and a synchroscan Streak camera with an overall time resolution of 8 ps⁴⁴. All the measurements are performed at $T = 50$ K.
